

This may be a second entry in addition to the Driving Trial or a stand-alone entry. If a second entry using the same horse, it must compete in a different dressage test and/or cones class <b>or</b> one of the entries must be H/C. There are no overall awards for the CT.</p> <p><b>Entry limit</b> - Athletes may enter either two DT, two CT or one DT and one CT – use separate <a href="#">CAC Entry Forms</a> for each entry.</p>
